**Clear Lake Water testing**: Feyo reported veligers (zebra mussel eggs) samples taken in July did not have any vilegers eggs in the sample. Also, the water tests in August indicated minimal amounts of phosphates and nitrates which indicates that the lake is in great shape

**Boat Landing Inspections:** A boat inspector is stationed at the public boat access at usage time

**Clear Lake water level management:** A motion was made to expend up to \$2000 for managing blockage of the lake outlet, motion was amended to have DNR permits before any work would be done.

**4th of July Parade and Boat Parade:** Rick Hults reported that the 4<sup>th</sup> of July land parade had 90 units, and the boat parade had 29 units.

**2ed Annual 5 K Run:** Sponsored by the Glen Store with 273 participants.
