Treasurer's Report

Gretchen Paulson presented the current financial condition of the Clear Lake Association for the period of August 30, 2015 to August 30, 2016.

Current Balance as of August 30, 2016 is **\$7,176.73.** The previously reported balance on August 30, 2015 was **\$6,588.89** showing a net increase of **\$587.84.** Paid members count to-date for 2016 stood at 51.

- Lake Level Report: Dave Kohanek reported that on:
 - July 11, 2016 the level of Clear Lake was at 1298.11 asl (which was 1.5" higher than the previously recorded all time high)
 - September 3, 2016 the level of Clear Lake was at 1297.65 asl.

As a point of reference, *Normal High Water Level* of Clear Lake as established by the MN DNR is: **1297.40.** Notable CL readings:

- 2014: (May 01) 1297.92
- 2015: (May 01) 1297.50 and (Sept 30): 1297.40
- o 2016: (May 01) 1297.78 and (May 27): 1297.60

NOTE: Highest recorded level was 1297.99 in April 1, 1966)

 - A motion was made by Bill Feyo and seconded by Tony Crea to reimburse Bruce Browne in the amount of \$300.00 for expense incurred in eradicating a beaver dam blockage along the SW and NW corners of the llake.

 Motion was made by Bill Feyo and seconded by Sue Miller to authorize the CLA Board of Directors to expend up to \$2,000 for managing blockage and the ongoing lake drainage management caused by beavers and other natural causes. Motion was amended to require a DNR permit before the work was to start. Motion for amendment was approved.
